

Terms and Conditions | Governance Top 100 – 2024

1.0 Definitions

ASX Listed means a company listed on the Australian Stock Exchange.

Event means Governance Top 100 - 2024, which is a competition of skill where governance professionals who are employed in an in-house governance role who are nominated (self-nominated or third party nominated) based on the terms and conditions of the Event and a winner is selected by the Judging Panel. The Event is designed to recognise individual governance professional's commitment and contribution to the governance profession in Australia.

Event Website means www.governancetop100.com.au

Force Majeure Event means an event beyond the reasonable control of a party including:

- (a) act of nature;
- (b) war or terrorism;
- (c) national emergency;
- (d) epidemic; and
- (e) act or inaction of government or regulatory agency;

which directly affects the party's ability to perform its obligations arising under this Agreement and cannot be mitigated by taking reasonable steps.

By entering the Governance Top 100 Event (Event), the nominee agrees to these terms and conditions, the Event Website terms of use and privacy policy. If you are nominating a third party, you acknowledge that they agree to be bound by these terms and conditions.

Nomination Criteria

- 1. The nominee must be 18 years and over.
- 2. The nominee must be an Australian resident or citizen, or if an overseas resident work for an



Australian registered entity.

- 3. The nominee must be a governance professional (for example: a company secretary, assistant company secretary, general counsel, risk manager, chairperson, director, CFO or other C-Suite executive) working in-house for a current registered Australian entity. This may include a government agency, public sector entity, not-for-profit, small or large proprietary company, public unlisted or ASX Listed company.
- 4. The nominee must not have been convicted of an offence under any law of the commonwealth a state or territory within the last 10 years and must not be an undischarged bankrupt.
- 5. The nominee must be a fit and proper person.
- 6. The nominee cannot be an employee of the Organiser or a Sponsor.
- 7. The nominee can be nominated as an entrant into the Event only once. Only the first valid entry will be accepted.

- (q) No. of employees
- (r) Provide responses to the following:
 - (i) How have you contributed to enhancing governance within your organisation in the last 12 months and how has that benefited your organisation (up to a maximum of 250 words).
 - (ii) What would it mean to you as a governance professional to be named the winner of Governance Top 100? (in 25 words or less).

A nomination will be excluded if:

- (i) It is received after the closing date;
- (ii) It is incomplete in any respect;
- (iii) You are no longer employed in your nominated Entity at the date of Judging.
- (iv) If it does not fulfill these terms and conditions.
